

HUNTING PERMIT

ANY persons' acquiring a Hunting Permit MUST be a current Shareholder or a descendant of a Shareholder. This person MUST produce and carry a current New Zealand Firearms Licence.

Hunting permits are issued with these conditions:

- If in a party, the Shareholder/descendant WILL BE designated responsible for that party. This person must produce and carry a current New Zealand Firearms Licence in their name.
- The above licence MUST be sighted by the delegated Ōtakanini Tōpū Incorporation representative.
- This Permit authorises ground based non-commercial hunting within the timeframe specified as "validity period", unless otherwise stated.
- The Permit is only valid for the area specified in the map associated with the permit area.
- Hunters using a firearm must abide by the NZ Police Arms Code and the Arms Act 1983.
- The maximum persons in a Hunting Party is NOT to exceed 4 persons.
- Maximum of 2 (two) guns permitted per hunting party in the same vehicle. Both gun holders MUST be either Shareholders or descendants of a Shareholder. They MUST produce and carry a current New Zealand Firearms Licence in their name. These are to be sighted by delegated Ōtakanini Tōpū Incorporation representative.
- Maximum of 1 (one) vehicle per hunting party.
- Hunting Party must text the delegated Ōtakanini Tōpū Incorporation representative when on farm.
- Hunting Party must text the delegated Ōtakanini Topū Incorporation representative when off farm.
- Avoid hazards, slippery tracks and fallen trees.
- Carcasses and offal must not be left behind.
- The Permit does not confer the right to take dogs on to the property.
- No firearms shall be discharged in a manner that endangers, frightens or annoys members of the public.
- No firearms shall be discharged in a manner that endangers any property.
- Respect of all farm livestock whilst travelling on the farm.
- Leave gates as you found them.

- Report all incidents and accidents or hazards to the Operation Manager.
- In case of an Emergency DIAL 111.
- You MUST not be under the influence of alcohol or illegal substances.
- Failure to adhere to any conditions of this Permit renders this Permit null and void and could result in future Hunting Permit requests being declined.

Terms and Conditions of Farm Access:

Rubbish:

The dumping of rubbish is strictly prohibited. All rubbish must be removed.

Fires:

Lighting of fires is prohibited. No smoking in the Forest. Dial 111 (if you see fire in the Forest).

Poison/Traps:

Poison and traps are used from time to time on the Farm. DO NOT touch any baits, lures, carcasses or traps.

Hazards/Risks:

The permit holder acknowledges that the Farm is a place of potential hazards and all proper care in exercising this permit including being responsible for those persons accompanying the permit holder. The permit holder agrees to enter the farm at their own risk and shall be solely responsible for those persons accompanying the permit holder. The permit holder releases to the full extent permitted by law, the Farm employees and agents from all liabilities, fines and demands of any kind which may arise out of any incident, accident or injury occurring to any person or property in the exercise of this permit. Ōtakanini Tōpu Incorporation makes no representation whatsoever as to the suitability of the Farm and/or Forest for the purpose intended by the permit holder.

Indemnity:

The permit holder shall indemnify Ōtakanini Tōpū Incorporation in respect of: (a) loss, damage or injury to real property of Ōtakanini Tōpū Incorporation, (b) any loss, damage or injury to the property of Ōtakanini Tōpū Incorporation or any person on the Land, (c) All claims or actions by any third party against Ōtakanini Tōpū Incorporation for any loss, damage, fines proceedings or injuries; where such loss, damages, fines or injury result arise out of the permit holder's presence (or those persons who accompany the permit holder) on the farm and/or forest or from the permit holders use of the tracks and roads or the undertaking of the rights under this permit.

Permit Requirements:

This permit must be carried at all times and produced on demand whilst the holder is within the Farm and/or Forest. This permit is not transferrable and maybe revoked at any time by notice given by or on behalf of the Ōtakanini Tōpū Incorporation, either verbally or by public notice or by advertisement. The permit holder must comply with all reasonable directions issued by Ōtakanini Tōpū Incorporation staff. The permit holder and those persons accompanying the permit holder shall not interfere with Ōtakanini Tōpū Incorporation activities on the farm and/or forest. The permit holder shall not do anything or omit to do anything that may become or is an annoyance, nuisance, damage or disturbance to Ōtakanini Tōpū Incorporation land or owners of land adjoining the land. The permit holder shall be responsible for the actions of all persons accompanying the permit holder under the permit whilst on the farm and/or in

the forest. The permit holder shall immediately notify Otakanini Tōpū of any damage to the farm and/or forest area or any injuries to any person occurring within the farm.

Breach of Permit Conditions:

This permit will terminate immediately upon any breach of its terms.
